William Reynolds married Jane Milliken in Greene Co, TN, 1790

Notes on Reynolds Family Association line 37 by Tommy Joe Reynolds

Goal: Explore FANs to generate additional records and context around the life of the William Reynolds that married Jane Milliken in Greene County TN in 1790 to identify key family networks and their trajectories and clues towards William's parentage.

Context: Very few records of William Reynolds exist. Marriage bond, a couple of land transactions. Fortunately, he had a large family (many children) and allied families. Numerous places covered. Greene TN, Green KY, Central TN... his path westward, matches migration trajectories of many families just after the revolutionary war. The censuses for VA, TN and KY are lost for 1790 and 1800. Fortunately, good YDNA matches between descendants of William connect his Reynolds family to other Reynoldses (see group I.02 of the Reynolds YDNA project); but most of those YDNA branches diverge before the currently known record trail begins (~late 1700s).

Emerging conclusions:

- 1. Key connections between William's in-laws in Millikan & Beard families are demonstrated by land and marriage records. See map.
- 2. Millikan is variously spelled as Millican/Milliken/Milligan/etc. Like Reynolds/Runnels/Rennols/etc. these should be treated equivalently for the purposes of genealogy in periods before widespread literacy.
- 3. Several men in William's FAN network had been in service in TN territory in military service against Indians when eastern TN was the outer frontier prior to the Revolution. Following the Revolution, many of these servicemen migrated to territories that became Eastern Tennessee by moving "up" the valley of Virginia from Botetourt, Augusta, Highland, and Bath counties.
- 4. William's FANs (Millikans, Beards and others) were part of the flow "up" the valley into GCTN in the 1780s, then onto GCKY in 18XX, Bedford Co TN in 18XX, and on to northern AL in 18XX.
- 5. Many populating the valley of Virginia and Eastern Tennessee were Ulster Scots. They left Ireland and settled ~1740s, following John Lewis's settling on Borden Patent. Ulster Scots arrived in waves to the mid-Atlantic between 1717>1740s via ports of Philadelphia PA & Newcastle DE. Although some Ulster Scots stayed in these coastal areas, many moved along to Lancaster Co PA and settled along the Susquehannah. Later, as land in PA became more expensive, many moved up into the valley in 1740-1750s buffer b/w Indians. Scout service in part of valley that eventually became TN. Originally part of NC but probably thought in VA. For example James Millican Senior served along the Holstein, Nalachucky and French Broad rivers in 17XX.
- 6. Some evidence connects William & Jane to these migrating Scots Irish groups. Examples of these connections can be seen for example in autobiographical narratives of Henry Reynolds and James Milliken Sr that were captured in their revolutionary war applications.

Some chronological facts about William Reynolds and his associates:

Add 1740s/50s/60s/70s

1. 1783; Greene Co, TN, Tax:

a. **Reynolds**: David, Henry, Job¹, William

b. Millican: Alexander, James [Sr]

c. Beard: Hugh, John

- 2. 1787: Several FANs signed the "Petition of the Inhabitants of the Western Country" on the State of Franklin. James Milliken signed next to Hugh and Samuel Beard. James Jr and Thomas Millikan both signed as well, but not right next to James Sr and Beards. William and David Reynolds signed.
- 3. 1789 Nov 15: Thomas, Isaac and James **Milliken** witness deed from **Doherty**² to **Posey** for 100a on north side of Nolachucky River in "Greene County and State of North Carolina"³
- 4. 1788: A case between listed between Robt. Davis⁴ and James Miligan resulted in a 5s tax.⁵
- 5. 1790 Aug 23: Greene Co, TN. Marriage license bond (page 1 and 2) for William **Reynolds** and Jane **Miligan**. Security Thomas **Millikin** and James **Kinny**/"**Henrey**"⁶?. Tho's Millikin was not f/o Jane as an 1809 deed (cited in this doc) in Bedford Co states that she is d/o James Millikin Sr.
- 6. 1791 May 28 to July 11: From the "Southwest Territory Militia", a list is found of the Holston Treaty Guards, the roll of Captain Hugh Beard's Company of the Holston Treaty Guards, stationed near the mouth of the French Broad River, who were protecting the commissioners as they worked out the terms of the treaty between the Cherokees and the United States. Included in this list of guards in Hugh Beard's company are William **Reynolds**, Thomas **Milliken**, Isaac **Milliken**, John **Beard**, and Robert and John **Looney**.⁷
- 7. 1798 Oct: Sam'l and Jas Beard received 200a (each) grants on south side of Green River in Green Co. KY
- 8. Ancestry profile of Joseph Miller has good description of this land from Watson.
- 9. 1799 Feb 18: Green Co, KY. Wm <u>Reynolds</u> deed from James **Millican** "Senior" for 125a on Green River. Wm and Jane held this land until Oct 1807 when sold to Wm **Settles**. James **Mellican** rc'd 250a (same land?) from Wm **Butler** Nov 1798.
- 10. 1799 Mar 4: In deed transfer from Sam'l **Vance** to George **Harmon**⁸, reference made to James **Milliken's** Lot in Greenville "whereon he now lives".

A <u>will for a James Henry</u> was proven in Greene Co. on 27 Jan 1834. Mins book? 17, p 309. This appears to be the James Henry listed <u>at WikiTree</u> based on date of death and name of oldest son, Nathaniel Henry. His FAG is here: #45641842.

Another James Henry, per this, is a DAR patriot that drowned in Little River in Greene Co. in 1792. Where was this James's land? Another James Henry, per this, lived in Greene Co. until at least 1806. WB G-M, p202. Where was this James's land?

One <u>James Henry</u> married (1776) Jane McNabb (1756-1812), sister of <u>Captain David McNabb Sr</u>, who was commander of James Millikin and William Coleman's company that marched from Washington Co., NC, in Sept 1781. Where was this James's land? He is in DAR: Ancestor #: A053759. Find-a-grave #41933478

On Jan 9, 1796, a James Henry received land from Thos McCollum on the west fork of Mill Creek on Big Limestone in Greene Co. DB 2:458.

- 11. 1799 May 13: Green Co, KY. Thos and Jas **Millikins** recorded/received land grants on Sulphur Lick Creek. By rules of grant, they should have been 21 y/o and already lived on land for 1 year. It appears Thos's 200a grant was passed along to Hugh **Beard** later same month. Not clear if it was because Thomas was moving? Where was Thos in 1800 census? Thos was not on the Green (or Adair) tax lists after 1799.
- 12. 1804 May 7: Adair Co, KY. Henry <u>Reynolds</u> deed from Joseph **Miller**¹⁰ for 50a on Sulphur Fork Creek, which feeds into Russell Creek right at Green/Adair Co line—Adair formed 1801. 11 (Note: need to disambiguate this Henry... looks like it's Leslie Stewart's vice Henry 1757.)
- 13. 1806 Jan 6: Adair Co Court Order (Vol A) for a road survey to be conducted by Archibald Wheeler Sr. Road to be from Columbia to **Doak's** ferry on Green river—section between Columbia and William **Rinnolds** Old Mill. Watson's 2001 Adair Co History asserts that Reynold's Creek was named for the family of Wm. **Reynolds**, an early Green River settler. Where was that located? Off Green River? Off Russell Creek? Off Sulphur Creek?
- 14. 1807 Mar: Joseph and Lilly Miller deed 200a to Hugh Beard. Adair? Cite needed.

15. (when Jane et al moved to Bedford?)

- 16. 1807 Oct 14: Adair KY. Wm and Jane **Reynolds** deed 125a pm Green River to Wm **Settles**. Jane's dower release 1811. Wm **Settles** also recipient of 200a in 1808 from James **Melican**. Need to find this deed, which was conveyed by POA from Daniel **Stilwell**, possibly because James **Melican** moved to Bedford? **Settles** gave <u>detailed deposition</u> against Wm **Tupman** in Adair in 1828. Wm had bro Benjamin **Settles**.
- 17. 1809 Feb 14: Deed from James **Millikin** Sr to "daughter" Jane **Reynolds**, both of Bedford Co, TN, of "negro woman named Cate and her child George" 12. This deed was not recorded until November 1836, when it was recorded immediately before recording of a 1835 deed of land from John **Reynolds** (Janes's son) to John **Sutton** for 75a on Big Flat Creek.
- 18. 1813 Oct 5: Account of the sale of property of James Milican Jr., dec'd, in Maury Co., TN¹³. Thos Milikan Adm. The following bought property: Elizabeth Milican (mother), Thomas Milican (prob bro), Jane Reynolds (sister of James Jr & wife of William), James Milican (father), Isaac Milican (prob bro), NB Phillips, Isaac Butler, David Butler, Saml Beard.
- 19. 1814 Sept: Hugh **Beard** deed from Thomas **Milligan** in Bedford Co., TN.

- d. First-hand account of life exists in 1833 revolutionary war pension application.

- f. Per Tennesseans in the Revolutionary War, Surnames beginning with R¹⁹: Born In Sussex County, Pennsylvania "Some 25 Miles From Philadelphia," Pennsylvania. At The Age Of Four Or Five, He Was Moved To Staunton, Virginia. He Resided Near The "Cow Pastures" In Augusta When He Enlisted And In The Fall Of 1779, Moved To Washington County, North Carolina, That Part That Became Greene County, Tennessee. He Also Enlisted Here And Was A Resident Of This County When He Applied For His Pension On 8 Feb 1833 At The Age Of 76. He Died Prior To 29 Nov 1836, Leaving A Widow Whow Was Not Named. She (Extracted From Rev. War Pension File, S4079). Private, Virginia Militia, \$45.00 Annual Allowance \$112.50 Amount Received July 6 1833 Pension Started Age 77 (1835 TN Pension Roll) See also: Thomas Morgan Revolutionary War Pension Application.²⁰
- g. This is not the same Henry that appears later of GCKY because his rev war pension app says he stayed in GCTN.

- b. 1787: Signed "Petition of the Inhabitants of the Western Country" on the State of Franklin. Signed next to Hugh and Samuel Beard. James Jr and Thomas Millikan both signed as well, but not right next to James Sr and Beards. William and David Reynolds signed right next to one another. Joseph McMurtry signed very close to James Jr and Thomas Millikan.
- c. Would be good to identify land location at time of above.
- d. 1833 Revolutionary War Pension application filed in Cocke Co., TN, 25 has details on:
 - i. 1754 birth b/w Londonderry and Newcastle [DE]
 - ii. Service Holston, Nolichucky, French Broad
 - iii. 1788 became Captain
 - iv. William Coleman affidavit
 - v. Does the pension state that he lived in VAVA? Does service description match records on Fold3? Monongohelia service, like Henry 1757?

- c. Millikan served with John and Capt David **McNabb**. **McNabb's** widow's pension file notes this about their community church in Augusta Co (now Rockbridge Co): "in what was then Augusta County now Rockbridge Virginia by publication as was then the custom by Parson Graham the church pastor at that time at the Stone Meeting House"
